### **DISCIPLINARY PROCEDURES FOR BOTHASIG AFC MEMBERS**

- 1.1** Any member whom is allegedly accused of wilfully breaking or disregarding any of the rules or who is accused of being guilty of conduct (whether in or out of the Club premises) unbecoming of a member, or conduct which in the opinion of the Club is injurious or calculated to be injurious to the good name, character and interest of the Club, shall be suspended as from when the Executive Committee become aware of such discretion at which time such member will be notified, via written notice, by the designated official of the club. The discretion of whether the member's misconduct warrants suspension remains solely with the Executive Committee of Bothasig AFC.
- 1.2** The official of the Club shall then notify said member, via written confirmation (**ANNEXURE A**), of the pending disciplinary enquiry which is to be served upon the member at least one week prior the scheduled enquiry.
- 1.3** The Club shall endeavour to conduct said enquiry, where reasonable, within 10 days of when the offence was committed (i.e. If offence was committed on the Saturday then the enquiry should take place no later than the second Tuesday thereafter) so as to alleviate the possibility of the member having to miss more than one game on suspension should the enquiry reveal that the member had not misconducted him/herself.
- 1.4** The Disciplinary Committee shall consist of an independent Chairperson, a Club initiator as well as a minimum of two Executive Committee members which may include the Club Captain, should he not be requested to represent the club member. The accused may also produce any material witness he/she wishes to testify on their behalf. Should the member fail to appear at the enquiry, without just cause, (**shall immediately be suspended until such time as he/she does appear.**) the enquiry will be rescheduled within seven days where should he/she once again fail to appear, without just cause, the enquiry will continue in his/her absence.
- 1.5** If a member is found guilty of misconduct he/she must be notified immediately after the DC's findings. The member shall be asked if he/she wishes to appeal against the penalty handed down by the DC. If the member wishes to appeal the penalty the section on the prescribed form, as per (**ANNEXURE B**), reserved for an appeal shall be completed.
- 1.6** Should a member wish to appeal the finding of the DC, all relevant forms pertaining to the initial charges must be forwarded to the Committee of the Bothasig FMC whereupon an Appeal Committee will be formed consisting of at least three (3) committee members, one of which shall be the Club Captain. Any person who presided at the initial enquiry shall not be eligible to serve on the Appeal Committee. The Chairperson of the Appeal Committee shall in no way be familiar with the initial hearing. The appellant may request that his/her Club Captain be in attendance, which must be acceded to. Appeal procedures must be implemented within seven (7) days of the appeal so as not to prejudice the member in any way.
- 1.7** The Bothasig FMC Appeal Committee shall have the power to enforce the following: Overturn the findings of the Club DC, Reduce or increase any penalty incurred by the member under the Club DC.
- 1.8** Should the members conduct warrant an appearance at the CTTFA Disciplinary he/she would be entitled to representation from any member of the Bothasig AFC whom agrees to assist, including the Club Captain, however should the verdict be of a guilty nature said member will receive a standard fine of R100.00 of which R50.00 would be used to retrieve the members card from the District. In the case of a junior member the parent whom signs the disciplinary code of conduct shall be liable. No member shall be eligible to play for Bothasig AFC until such time as the fine is paid and should this not occur by the end of the playing season then the members clearance shall be withheld until such time as the outstanding amount is settled.

#### **PROPOSED SANCTIONS:**

Conduct where the member is not required to report to the district:

1. Swearing on the field in the presence of spectators:
  - 1.1 Warning (**or at the discretion of the EXCO**)
  - 1.2 One Game suspension
  - 1.3 Three Game suspension

2. Enticement of opposing players or spectators:
  - 2.1 Warning **(or at the discretion of the EXCO)**
  - 2.2 One Game suspension
  - 3.3 Three Game suspension
3. Drunk and Disorderly behaviour:
  - 3.1 Warning **(or at the discretion of the EXCO)**
  - 3.2 One Game suspension
  - 3.3 Three Game suspension
4. Fighting (off the field of play)
  - 4.1 Three Game suspension **(or at the discretion of the EXCO)**
  - 4.2 Expulsion
5. Damage to Bothasig AFC property
  - 5.1 Three Game suspension **(or at the discretion of the EXCO)**
  - 5.2 Expulsion
